

Chendrappini Fishing Village

(Edathuruthy Grama Panchayat -Mathilakom Block)

A Brief Profile of the Chendrappini Fishing Villages

Chendrappini fisheries village is located in ward 9 of Edathuruthy Gram Panchayat. The village has a total of 175 houses and 230 households are living there. Among them, 58 are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 57.14 percent houses are pucca, 31.43 percent are semi-pucca and 11.43 percent houses are kachha houses. About 62.86 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 62.86 percent of the existing houses. Most of the houses in the village (94.29 %) are electrified. It is noted that 89 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 9 persons are covered under the old age pension scheme and 4 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has one SC and one PHC. The village has one High School and Higher Secondary School. One anganawadi is functioning in this village and it is functioning in its own building. This village has 2 roads of 3.50 km length, 1.25 Km drainage and 2 culverts. The village has 62 street lights and 58 of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 5 country fishing boats are available in this fisheries village. And a total of 2 kerosene permits are issued to the fisher folk in this. The village has a protected coastal line of 0.80 Km length. Consumption of liquor and narcotic drugs are moderate in this village.
