

## **Nattika Fishing Village**

(Nattika Grama Panchayat - (Thalikulam Block))

### ***A Brief Profile of the Nattika Fishing Villages***

Nattika fisheries village is spread over three wards of Nattika Gram Panchayat. The coastal wards of this village are 1, 12 and 13. The village has a total of 675 houses and 730 households are living there. Among them, 61 are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 31.11 percent houses are pucca, 31.26 percent are semi-pucca and 37.63 percent houses are kachha houses. About 95.56 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 69.93 percent of the existing houses. Most of the houses in the village (91.11 %) are electrified. It is noted that 324 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 31 persons are covered under the old age pension scheme and 9 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has one PHC and one Ayurveda hospital. The village has one LP School and one Higher Secondary School. Four anganawadis are functioning in this village and three of them are functioning in its own building. This village has 6 roads of 6.75 km length, 3 Km drainage and 8 culverts. The village has 85 street lights and only 30 of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 180 country fishing boats and 20 mechanized boats are available in this fisheries village. And a total of 121 kerosene permits are issued to the fisher folk in this. The village has landing centre and one guide light. The village has two ice plants. The village has coastal line of 3.40 Km and out which 2 Km is protected. Consumption of liquor and narcotic drugs are acute in this village.
